### RELATIONSHIP REBATE FOR MEMBERS

Because you're a member of Orange Credit Union, we're giving you the first \$5.00 of your transaction costs to spend however you would like. If you're under 18 years of age, you'll receive an additional \$5.00 rebate each month. The rebate structure allows for all members to have access to at least 3 over-the-counter withdrawals in the month—or if you prefer ATM or eftpos transactions, you will be able to withdraw 4 or 5 times (respectively) per month before you may incur transaction fees.

Simply, the more business you have with us, the more "rebates" you'll receive each month toward your transaction choices. The relationship rebate will be based on your average monthly balance<sup>1</sup> in the following bands:

NOTES: 1. Balance of savings, investments and loans (Base Variable Home Loan, Essential Fixed and Essential Low rate loans excluded) 2. Every member receives a rebate of at least \$5.00 per month—under 18 years of age will receive an additional \$5.00 each month. 3. Relationship Rebate does not apply to Base Variable Rate Home Loan. 4. Effective 1 September 2021, a \$2.00 fee per mailed statement will be charged for all deposit and loan accounts (or both which are presented in a single statement. The \$2.00 fee will be applied to your transaction account at the end of the month and appear on your next statement. Excludes club accounts and accounts held by members under age 18 years. 5. Fee plus a rate reduction based on: 0 to 30% of term elapsed—30% of the initial rate; 31 to 60% of term elapsed—60% of the initial rate; 61 to 90% of term elapsed—90% of the initial rate. A minimum of 0.10% penalty interest will also apply to the portion of the deposit that is redeemed prior to maturity. 6. Members over 65 years of age are exempt. 7. Applies to any account on which transactions have not occurred for 12 months. 8. Applies to any membership on which transactions have not occurred for 7 years and funds are to be transferred to Government Treasury Department. 9. Exemptions to apply to members with the following: Orange Credit Union residential or investment home loan (excluding Base Variable Rate and Essential home loan borrowers); Average balance above \$10,000; and members aged younger than 16 years or older than 65 years. 10. Fee of 2% of the transaction amount will apply to any overseas Visa Card transaction. 11.
